Honoring the Sacrifice Foundation GREAT Golf Cart Giveaway Raffle

All proceeds from The Honoring the Sacrifice Foundation (HTS), Great Golf Cart Giveaway Raffle go to fulfilling the mission of the foundation in providing direct assistance and meeting the unique needs of the severely-wounded men and women who fought for the freedoms we enjoy. VOID WHERE PROHIBITED BY LAW. Subject to all applicable federal, state, and local laws, regulations and ordinances. Tickets may sell out before the date of the raffle drawing. The chances of winning are based on the number of tickets sold.

1. You must be a U.S. legal resident and 18 years of age to purchase a ticket and win. Board members of HTS and their immediate families are not eligible to participate. Media sponsors, their employees and their immediate families are also not eligible to win.
2. A ticket sold to an ineligible person is void and cannot be a winning ticket. No refunds will be made to ineligible purchasers, except in sole and absolute discretion of HTS.
3. The purchase price for one (1) raffle ticket is \$20, or 6 for \$100. Only 1,000 tickets will be sold. All ticket sales are final, and no refunds will be paid. Tickets prizes, receipts, and any winner's rights are non-transferable.
4. All ticket purchases must be received and/or purchased by the contest deadline. Any orders received after the deadline will be ineligible. HTS assumes no responsibility for lost, late, misdirected or non-delivered mail, email, or fax messages, or any other failure to receive orders or delivery receipts prior to the drawing deadline. All defective or physically altered tickets may be disqualified.
5. Tickets may be purchased from any HTS Board member, authorized volunteer or online at honoringthesacrifice.org.
6. Tickets may be purchased with a check, cash, or credit card. If an entrant's check is returned unpaid by the bank, the entry ticket(s) will be invalid unless a cash payment is received by HTS by 11 :00 a.m. Eastern Time Thursday, October 15, 2020, the official raffle deadline.
7. Purchaser must provide all required information to be eligible to enter and win. Incomplete, illegible, corrupted, or untimely entries are void and will be disqualified.
8. All ticket entry purchases are final and non-refundable.
9. Entrant will retain the original printed raffle ticket. The stub will be entered into the drawing and will be retained by HTS. If purchased online, the ticket numbers will be emailed to the purchaser and the physical raffle ticket(s) will be mailed to the address provided by the Entrant at the time of sale and HTS will retain the stub.
10. All unsold tickets and proceeds from the raffle ticket sales must be received by HTS no later than 11 :00 a.m. Eastern Time, Thursday, October 15, 2020. If received after the official deadline, all monies will be returned to entrant(s) and associated tickets will be invalid.
11. The winner of the raffle will be determined by a random drawing. All tickets have an equal chance to win. The drawing will take place on Friday, October 16, 2020. You do not need to be present to win. A video of this drawing will be posted online at honoringthesacrifice.org and on the HTS Facebook page. Winners will be notified by email and phone and announced by US101 radio station.
12. The drawn winner of the raffle is entitled to receive a Club Car Tempo Electric 4-seat golf cart. HTS specifically disclaims all expressed or implied warranties, including without limitations warranties of merchantability. HTS is not responsible for any losses or injuries suffered as a result of the raffle prize
13. Winners agree to comply with all IRS regulations regarding raffle winnings. The winner agrees to furnish HTS with his/her Social Security number, verify his/her identity, and sign all required IRS documents before claiming the raffle prize. HTS does not offer any Tax advice. Please consult a CPA if you have any tax related questions.
14. The winner is solely responsible for payment of all federal, state, or local income, sales, or use taxes and fees based on the value of the prize. The value of the prize is based on the manufacturer's suggested retail price of the golf cart. HTS takes no responsibility for any tax liabilities. Winners should consult a tax professional.
15. The winner of the HTS Great Golf Cart Giveaway raffle must claim the prize within 30 (30) days of the drawing. If the winner does not claim the prize within 30 days by responding to phone or written notice by HTS or otherwise, the prize will be forfeited.
16. After the prize is claimed the winner is responsible for taking possession of the golf cart and all costs for any

transportation related to taking possession of the prize.

17. Purchasers of the raffle tickets must legibly write their full legal name, address, e-mail and/or telephone number on each individual ticket stub. If there is more than one name on the ticket stub, the first listed name shall be the Entrant. HTS will have no obligation for payment or delivery of any prize to any person other than the Entrant.
